Anchor has had a brilliant year. The insolvency of the KNV Group, a major player in the German publishing landscape, kept the firm on its toes with demanding major proceedings held at the Local Court of Stuttgart, a stage highly sought after by many competitors. With **Tobias Wahl**, an experienced and widely esteemed administrator officially took the reins for KNV. The fact that KNV did not turn into an ego trip for the administrator but remained an Anchor lawsuit says a lot about the firm – just like the proceedings for kitchen manufacturer Alno the previous year, where **Professor Martin Hörmann** took the lead. Since being founded, the firm has always spread all its challenges across numerous shoulders, even turn-

ing restructuring matters into a team assignment – irrelevant of whether the instruction comes from an insolvency court or a client. When **Alexander Reus** and **Vincenz von Braun** were appointed to act as managing directors of the Eurocoles Group and its 1,200-strong workforce to carry out self-administered restructuring measures, it went without saying that they were able to rely on the same team of virtuoso experts that were also handling the cases for the insolvency court. Moreover, with the management company that joined forces with the law firm three years ago, the operational and business administration know-how required for long-term corporate rescue matters has grown even more.

Insolvency Administration/Trusteeships



Comment: Alongside its specialties in corporate rescue advice and insolvency administration, Anchor has also focused on crisis-related corporate and, in particular, management advice for a couple of years now. The insolvency of supporting systems manufacturer Europoles drew from the firm's experience in precisely these areas: two lawyers were appointed to the management of the company to assist in self-administration matters.
